

Elvie Competition Terms and Conditions

1. This competition is open to residents of the UK, Channel Islands, Isle of Man and the Republic of Ireland aged 18 years or over. This competition is not open to employees or agents of the organiser; Mamas & Papas (Retail) Limited, a company incorporated in England and Wales with company registration number 01529849 and whose registered office is situated at Colne Bridge Road, Huddersfield, HD5 0RH, or any of its associated companies (**"Mamas & Papas"**). **This is a free competition. Entrants are not required to make any purchase to enter.** Only one entry may be made per person. By entering this competition, applicants agree to be bound by these terms and conditions.
